**DECISION** 

The summary regarding additional storey / FAR was discussed in Board meeting and it was concluded that the proposed sudden rise in rates are practically not applicable and hence, incremental increase be considered to achieve the required targets subject to review by the Board. The Board therefore approved the following:

- i. The proposal at para 4-(i) of summary after deliberation has been modified and 50% of the proposed rates of prevailing market price mentioned in Col-6 of Annexure-"A" stand approved.
- ii. For additional covered area in basements without commercial use, 25% of approved rates at (i) above and in case of commercial use, full rates as mentioned at (i) above are to be charged.
- iii. In case of un-authorized additional storey, a penalty of minimum Rs. 1000/- per sft <u>OR</u> 25% of approved rates, whichever is higher, shall be applicable. The said charges will be in addition to additional covered area/ FAR approved rates mentioned at i above.
- iv. The proposed rates are for additional storey / FAR are only for financial calculation purposes and the decision to allow any additional storey / FAR or otherwise will purely be the responsibility and domain of Planning Wing.
