After review, the CDA Board took up items included in the agenda for the current meeting one by one. Brief account of the discussion/deliberations held and decisions taken are summarized below:-

d) Delay in disposal of cases by different Formations of CDA.

 $\frac{5948/822/94}{13-11-94}$  CDA Board took serious notice of the abnormal  $\frac{726/BF}{13-11-94}$  delays in disposal of respective cases by some

of the officers/officials of CDA. The efficiency has not been improved by some of the officers inspite of repeated verbal and written warnings by Chairman and Board Members.

In order to improve upon the general efficiency in the working of CDA and in order to compel officers not to delay the cases, the Board decided to take strict disciplinary action against those who do not work hard and are not careful in doing their duties. Board decided following:-

- i) No officer upto the level of BPS-16 shall delay the disposal of any case/PUC (including preparation of PC-I, periodical reports, estimates, calling tenders, deciding tenders, starting work etc. etc., by engineers) for a period more than a week inclusive of Friday, Saturday and Holidays.
- ii) If any officer fails to comply with above for three times, he would be reverted from his position to the lower rank. If any officer is found to delay more than ten cases he would be terminated from service.

- iii) Action against the defaulting officer is to be initiated by his immediate boss. In case immediate boss ignores/fails to take action against his subordinate then the same punishment would be given to such higher officer.
  - of only Show Cause Notice without formally appointing an Inquiry Officer and conducting formal enquiry.
    - v) Amendment in the disciplinary rules may be made accordingly.
