13.1 REQUEST FOR ALLOTMENT OF LAND FOR CONSTRUCTION OF BOARD OF 10937/1327/BM/'17 INVESTMENT (BOI) BUILDING.

DECISION

The request for allocation of land for construction of Building for Board of Investment was presented to the Board. The Board after due deliberation, concluded that option for allocation of plot numbers 15-B and 15-C as mentioned in para 7 of the summary match with the covered area requirements of BOI. 13.2 REVISION OF FEE/ CHARGES ASSOCIATED WITH NOCS FOR PETROL BM/'17 PUMP/ CNG STATIONS IN ICT, ISLAMABAD.

DECISION

After due deliberation, revision of fee/charges for Petrol Pump/CNG Stations was decided as follows:

1. Para 3 Sr. 1

Land use conversion fee be increased @ 50% of the existing Fee/Charges from Rs. 2,500/- to Rs. 3750/- for Urban Areas and Rs. 1,250/- to Rs. 1,875/- for Rural Areas.

2. Para 3 Sr. 2

Scrutiny fee (one time) be increased @ 100% of the existing charges from Rs. 125,000/- to Rs. 250,000/- to be charged at the time of submission of the application.

3. Para 3 Sr. 3

Annual Departmental Charges be increased @ 100% of the existing charges from Rs. 25,000/- to Rs. 50,000/- to be charged per annum after issuance of NOC.

4. Para 3 Sr. 4

Charges for permission of additional facility on already approved Petrol Pump/CNG Station be increased @ 100% of the existing charges from Rs. 500,000/- to Rs. 1,000,000/- to be charged once before permission is granted.

5. <u>Para 3 Sr. 5</u>

In the light of item 6.4 of CDA Board decision dated 19 May 2017, provision at Sr. No. 5 stands deleted.
