6.2 <u>REQUEST FOR ISSUANCE OF NOC FOR HOUSING SCHEME NAMELY</u> 11348/1384/BM/'21 <u>PARADISE CITY IN SECTOR F-16, F-17 AND G-17, ZONE-II ISLAMABAD.</u> 09-07-'21/6TH

DECISION

The summary was presented by Member (P&D) CDA. The case was discussed in detail and during the discussion, it was pointed out that the matter had also been reported in media that the land of the subject scheme was scattered. The Board was of the view that the sale and marketing of any housing scheme should be restricted during the processing of LOP and NOC. The members of the Board highlighted that the aspect of Audit Para has not been incorporated in the summary, whereby the audit Para was settled by the PAC with the directions to the Authority that if the sponsors of the scheme fulfill the requisite conditions / formalities their case may be considered under the prevailing rules and regulations.

It was further pointed out by Director (HS) that the provision of ROW for principal roads and transfer of its 145 kanals land ownership in favor of CDA is a mandatory requirement for the sponsors of the scheme.

After due deliberation and on the basis of information/inputs of the summary, the board was of the view that observations mentioned in the list have not yet been fulfilled. Planning Wing is, therefore directed to explain as to whether the sponsors have to fulfill the said requirements. In case the same are mandatory then Planning Wing may ensure their compliance and submit before the Board after completing all requisite formalities. In case the same are not mandatory conditions, a certificate to the effect may be issued. The subject case would be presented to the board within a week's time.
