1) WATER SUPPLY POSITION IN ISLAMABAD.

After considering the working paper prepared by the Director Maintenance, following observations/decisions were made: -

The output of each tubewell is based on a) conjecture. The need for adopting scientific method of finding out-put of each tubewell was stressed and in this connection it was desired that the possibility of installing a water meter at each tubewell should be examined.

- b) To find out the exact out-put of each tube-well, for calculating the total availability of water exactly, it was decided that each tubewell should be operated one by one for one hour each on a day to be fixed in October and the measurement be done at Sump. Before undertaking this operation, it should be ensured that all the reservoirs are full and advance notice is published informing the residents of Islamabad about the interruption of water supply.
- c) The Director Maintenance would prepare plan of operation mentioned in (b) above and submit it to the Board for approval by the end of September, 1975.
- d) The file relating to the sanction of Second Conduction Main should be put up to the Chairman by the D.G.W. after tracing it in his office. The Finance Wing may also search for the file in its record as it is likely that it may be available with the Finance Wing.
- e) The exact number of more tubewells required may be determined soon after the water supply available from the existing tubewells has been accurately measured as a result of operation mentioned at (b) above. This operation must be completed by 10-10-1975.
- f) Estimate for cost of sinking of new tubewell should be prepared by Director W&S and it should be ready in all respects so that tenders can be called by 15-10-1975.
- g) Director W&S should be relieved of the dual charge so that efficiency of Water and Sewerage Directorate is improved.
- h) The two tubewells were sunk in Sector I-9 long ago but none so far has been commissioned. Chairman desired that a report should be submitted for the reasons of non-commissioning of these tubewells and the efforts made so far to commission them.
