9932/1207/BM/'11 (I) ALLOTMENT OF RESIDENTIAL PLOTS UNDER PRIME MINISTER'S PACKAGE FOR BS-22 OFFICERS.

DECISION

Keeping in view the contention of Federal Government Employees Housing Foundation (FGEHF) communicated vide letter No. 10(1)PMS/09-HF(Vol-IV) dated 24-03-2011 and progress of development works in the areas of Sector D-12 where the plots are located, the Board agreed to consider the request made by FGEHF and decided as under:-

- i) The surcharge / delayed payment charges already levied on the plots allotted to BS-22 officers shall be waived off up to 31-12-2009 as the D-12 Sector was inaugurated by the Prime Minister on 04-01-2010
- ii) Schedule of payment shall not be spread to 03 years instead of 1-1/2 years and no relaxation in payment of principle amount and / or surcharge / delayed payment charges shall be made beyond 31-12-2009.
