- a). CDA will allot land to the companies on specified rates.
- b). Building shall have to be undertaken by the companies according to the Building Plans approved by the CDA.
- c). Companies will invite applications for allotment of the houses to the displaced persons.
- d). The applications shall be forwarded by the companies for verification and approval, before making allotment, of the CDA. Allotment shall be made to those who are approved by CDA.
- e). For the allotment of constructed houses to displaced persons, CDA will give land at concessional rates as prescribed in this behalf.
- f). A penal clause should be inserted that if any information supplied by the companies is not found correct, the companies will be liable to pay a fine plus any penalty at the rates so levied by CDA.
- g). All the terms and conditions should be re-drafted keeping in view the above observations.

Thereafter, clause by clause reading was undertaken by the Board and following decisions were taken:-

Clauses 1 to 6 should be redrafted keeping in view the above observations.

Clause 7 - The word "Authority" should be substituted by the word "Company".

Clause 12 - should be deleted.

Another clause should be inserted in between clauses 13 & 14 that the Company shall make full payment to the CDA before a completion certificate was granted by CDA to the Company.

Clause 15 - In line 2, word "initially" shall be deleted and in line 3, the words begining from "&" ending to "allottees" should be deleted.
