APPOINTMENT OF STAFF FOR HEALTH SERVICES DIRECTORATE FOR DENGUE CONTROL, IN ISLAMABAD (STRENGTHENING OF DHS FOR DENGUE FEVER CONTROL).

DECISION:

The summary was deliberated and was principally approved subject to fulfilment of all government rules and codal formalities required for recruitment / appointment and approval of the Prime Minister of Pakistan.

However, it was decided that total cost to be incurred on recruitment of personnel, purchase of equipments and Dengue Operation Rooms shall be met from specific allocation to be provided by the Prime Minister of Pakistan.

TRANSFER OF CAPITAL HOSPITAL, METROPOLITAN CORPORATION ISLAMABAD TO CAPITAL DEVELOPMENT AUTHORITY, ISLAMABAD.

DECISION:

After Capital Hospital is fully functional under the administrative control of MCI, the expenditure incurred by the Capital Hospital on CDA employees shall be debited to CDA.

- Plot placed at Sr. No. 24 is deleted from the list due to certain expected impediments. Another plot No. 18, Orchard, measuring 2.50 acres, Orchard Scheme Murree Road was recommended by DDG (L&E) for inclusion in the list with token money 10 Million. The Board approved the proposal of DDG (L&E).
- The successful bidder shall deposit 25% of the total premium within 72 hours as per other requisites proposed vide para 5 of the summary.
- 75% of the remaining balance premium shall be deposited by the bidder in three equal instalments of 25% each as per schedule proposed vide para 5 "i,ii,iii".
- Accordingly the admissible rebate as mentioned in para-5 be read as follows:
 - i. If total premium is paid within 15 days (holidays excluded) of Bid Acceptance, a rebate @ 8% of 75% of the premium will be granted;
- The auction shall commence on 13 & 14 December.
