The Electronic Bids will be opened using EPADS publically on date & time mentioned above in the presence of the Procurement Committee & Bidders authorized Representatives who choose to attend the opening session to be held at the office of Director (Works), CDA Room No.21, Ground Floor, Old Naval HQ, G-6 Markaz, Islamabad.
